Swiss-Asian Chamber of Commerce Files Legal Charges Following Falsified Registration Incident

Press Release | Zurich, Switzerland - Sept 20. 2024

On or around August 20, 2024, Roger Leitner and Mark Dangel registered themselves, along with Andreas Weckherlin, Nathan Kaiser, Nilayini Vamatheva, Marco Ruocco, and Ariste Chiabotti, as signatories of the Swiss-Asian Chamber of Commerce (SACC). This registration was accomplished using a boldly falsified extract of a board resolution.

"We are deeply disappointed by the breach of trust caused by these individuals," said Dr. Urs Lustenberger, Chairman of the SACC Board. "Our commitment to transparency and accountability in business is unwavering, and we will ensure that those responsible for this deceitful registration are held accountable in accordance with the law."

Due to prior actions by these seven individuals aimed at undermining the Chamber through various means, the Board of Directors of the Swiss-Asian Chamber of Commerce (SACC) resolved, during its meeting on June 10, 2024, to expel them from the Chamber and had no authority to represent the Swiss-Asian Chamber of Commerce in any circumstances and capacity. This decision was formally announced to the public in a press release dated July 25, 2024. Despite their expulsion, their conduct has regrettably continued, culminating in the falsification and manipulation of documents in an attempt to deceive the registry in Switzerland.

The SACC has filed formal legal charges and cooperates fully with the authorities to ensure justice is served. The Chamber remains committed to maintaining the highest standards of ethics and professionalism across all its dealings. Until proven guilty and finally convicted, all named individuals are to be presumed innocent.

The Swiss-Asian Chamber of Commerce remains steadfast in its mission to promote strong and ethical commercial ties between Switzerland and Asian markets, and this incident only strengthens its resolve to protect the integrity of its members and partners.
